Delivering safe, reliable energy is an Eversource top priority. In keeping with that commitment, Eversource is improving the natural gas distribution system in your Bristol neighborhood, beginning the week of October 16, 2023, and continuing through approximately December 8th. As we perform our work, we are continuing to follow the guidance issued by federal, state and regulatory officials concerning certain job tasks during the coronavirus health crisis. What You Can Expect While We are In Your Neighborhood

Working together is important to the successful and timely completion of this project. NPL Construction will be performing the work in your neighborhood on behalf of Eversource. Construction activities will generally take place Monday through Friday, and occasionally on Saturdays, between 7 a.m. to 4:30 p.m. Our work is weather dependent, and construction activities are subject to change. All Eversource employees, contractors and field representatives carry identification they will gladly share with you. Construction will take place on the following streets:

- Beach Ave
- Dewey Ave
- Pearl St
- Fairview Ave
- Roosevelt Ave
- Ames Ave
- Allen St

If you are an Eversource gas customer, our work will include moving your natural gas meter outside, replacing your existing gas service line, and installing curb valves at the street. There may also be other upgrades required to ensure the safe and most efficient operation of the natural gas distribution system.

This work will result in a temporary interruption to your natural gas service. Please be assured, however, that prior to any interruption, you will be contacted in advance so that you can plan accordingly. At the conclusion of any gas service interruption, Eversource representatives will turn your natural gas meter back on, re-light all your natural gas appliances and perform a safety check. We will do our best to minimize any disruptions.

We are committed to being good neighbors and performing our work with the utmost respect for you and your property. As construction professionals, we also know that living within a work zone can be challenging.

During this time, Eversource will wear personal protective equipment, follow social distancing and abide by other federal and state health and safety guidelines.

- All employees and contractors **must self-certify** they are healthy before the start of their shift.
- Clearly identified **wash stations** are present at each construction site.
- **Hand sanitizer** and **disposable gloves** have been distributed to all employees and contractors.
- **Face coverings** are required by all employees and contractors when social distancing cannot be maintained.
- All employees and contractors are required to practice **social distancing** when around others.
- Eversource employees and contractors will seek access to private residences and businesses to perform critical work. In those instances, we will contact you in advance to **coordinate safe access**, execute **enhanced protective measures** when needed, and provide additional **personal protective equipment** (PPE) to field technicians.
- **We ask that you and others in your residence or business practice** social distancing and wear a face covering while our technician is in your residence/business.
