Requirements for Town of Plymouth Sewer Permits

1. **Copy of current state of Connecticut Plumbing or Drain layers License- P1 – P3 – P7 – W9**
2. **All Permits for Low Pressure Systems will only be issued to a Connecticut Plumber with a P1 License. The installation of Low-Pressure Sewer systems can only be completed by a P1 (or a P2 under the employment of a P1)**

In the absence of a licensed plumber a permit will only be issued if in compliance with section 20-338b of the CT General Statutes.

Sec. 20-338b.

Any licensed contractor who seeks to obtain a permit from a building official may sign the building permit application personally or delegate the signing of the building permit application to an employee, subcontractor or other agent of the licensed contractor, provided, the licensed contractor's employee, subcontractor or other agent submits to the building official a dated letter on the licensed contractor's letterhead, signed by the licensed contractor, stating that the bearer of the letter is authorized to sign the building permit application as the agent of the licensed contractor. The letter shall not be a copy or a facsimile, but shall be an original letter bearing the original signature of the licensed contractor. The letter shall also include: (1) The name of the municipality where the work is to be performed; (2) the job name or a description of the job; (3) the starting date of the job; (4) the name of the licensed contractor; (5) the name of the licensed contractor's agent; and (6) the license numbers of all contractors to be involved in the work.

3. **Certificate of Insurance**

\$50,000 - each accident

\$25,000 - each person

\$10,000 - property insurance in behalf of the Town of Plymouth, WPCA

4. **\$5,000 drain layers bond if working near/on the main sewer**

5. **Road opening Bond (if working in the road) which must be obtained at the Town Hall**

Town of Plymouth Sewer Connection Fees

1. Sewer Connection Fee - \$2,500

Consist of a fee paid to The Town of Plymouth WPCA for connecting to the sewer if no prior assessment was paid

2. Moving of line fee - \$500

This fee is charged whenever the length of a lateral connection increases or decreases from a point 30 inches outside the outer wall of a building or structure. The sewer Reconnection fee will be waived for class III and class IV food establishments complying with State of Connecticut, DEEP fats, oils and grease program with the installation of a grease unit

3. Permit Fee - \$100

A permit fee will apply to any sewer connection, disconnection, reconnection or repair

All Checks Made Out to: **Town of Plymouth WPCA**

Town of Plymouth Sewer Connection policies

1. No person shall excavate to uncover or locate any portion of any public sewer or private sewer line which discharges to a public sewer within the Town of Plymouth without first obtaining a permit from the Plymouth Water Pollution Control Authority.
2. No permits shall be issued unless a valid "Call Before You Dig Request" (Per Public Act No.87-71 and section 16-345 of the Regulations of Connecticut State Agencies has been received by the Plymouth Water Pollution Control Authority
3. The Town of Plymouth Water Pollution Control Authority shall only issue a permit to licensed plumbing contractors in the proper license classification within the trade to perform such work (Per Connecticut Consumer Protection Plumbing License Scope of Work Guidelines and CT General Statutes 20-330 – 20-341)
4. Permits are valid for 30 days. After 30 days a new permit must be obtained.
5. All connections will need to be inspected by the Plymouth WPCA before they are covered. All inspections require a 24 hour notice
